## Management Discussion of Fund Performance

November 13, 2023

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments that have affected the Fund's performance and outlook in the six-month period ended September 30, 2023 (the "period"). If the Fund was established during the period, "period" represents the period since inception.

In this report, "Mackenzie" and "the Manager" refer to Mackenzie Financial Corporation, the manager of the Fund. In addition, net asset value ("NAV") refers to the value of the Fund as calculated for transaction purposes, on which the discussion of Fund performance is based.

## Results of Operations

### Investment Performance

The performance of all series in the current and previous periods is shown in the *Past Performance* section of the report. Performance will vary by series primarily because fees and expenses differ between series, or because securities of a series were not issued and outstanding for the entire reporting period. Please refer to the *Fund Formation and Series Information* section of this report for the varying management and administration fees payable by each series. The following comparison to market indices is intended to help investors understand the Fund's performance relative to the general performance of the markets. However, the Fund's mandate may be different from that of the indices shown.

During the period, the Fund's Series A and Series LB securities returned -1.9% (after deducting fees and expenses paid by the series). This compares with the MSCI World (Net) Index return of 3.5%. All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, which are not reflected in the index returns.

Global equities rose over the period as central banks slowed the pace of their rate increases. The global economy proved resilient, and employment remained strong. With high inflation persisting, the U.S. Federal Reserve, European Central Bank and Bank of England increased their policy interest rates, albeit at a slower pace. Higher interest rates and inflation contributed to tight financial conditions, which weighed on demand and hindered manufacturing sector activity.

Within the MSCI World (Net) Index, Norway, Italy and the United States were the strongest-performing markets in Canadian dollar terms, while Hong Kong, New Zealand and Finland were the weakest. The communication services, energy and information technology sectors were the strongest performers, while utilities, consumer staples and real estate were the weakest.

The Fund underperformed the index, with stock selection in the United States, as well as an overweight position and stock selection in the United Kingdom, detracting from performance. In sector terms, stock selection in consumer staples and communication services detracted from performance.

Conversely, stock selection in the Netherlands contributed to performance, as did stock selection in the materials sector.

Over the period, neither portfolio activity nor market developments significantly changed the positioning of the Fund.

## Environmental, Social and Governance ("ESG") Impact

The portfolio management team employs a proprietary investment process that applies a gender leadership score based on a customized gender index of companies worldwide with the highest ratings in terms of advancing women. The index is reconstituted each year in December.

In the 2022 annual reconstitution, companies in the customized index had a weighted average of 39% for women on boards of directors and 32% for women in management. By comparison, companies in the MSCI World (Net) Index had a weighted average of 33% women board members and 25% women in management. Additionally, 38% of companies in the customized index had a female chief executive officer ("CEO") or chief financial officer ("CFO"), and 97% had three or more women on their boards. This compares to 18% with female CEOs or CFOs, and 72% with three or more female board members, for companies in the MSCI World (Net) Index.

Because the annual reconstitution did not occur within the period, there were no significant additions to the portfolio.

## Net Assets

The Fund's net assets decreased by 2.4% during the period to \$39.4 million. This change was composed primarily of \$0.6 million in net losses (including any interest and/or dividend income) from investment performance, after deducting fees and expenses, and a decrease of \$0.3 million due to net securityholder activity (including sales, redemptions and cash distributions).

## Fees and Expenses

The annualized management expense ratio ("MER") for each series during the period ended September 30, 2023, was generally similar to the MER for the year ended March 31, 2023. Total expenses paid vary from period to period mainly as a result of changes in average assets in each series. The MER for Series T5 decreased due to changes in its applicable Harmonized Sales Tax rate. The MER for Series T8 decreased due to changes in its average net assets. The MERs for all series are presented in the *Financial Highlights* section of this report.

## Recent Developments

The weight of each holding in the Fund is based on its gender leadership score and the portfolio management team's assessment of risk. As such, the team does not generate market expectations or make investment decisions according to any macroeconomic forecast.

## Related Party Transactions

### Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees to the Manager at the annual rates specified under *Fund Formation and Series Information* in this report and as more fully described in the Prospectus. In return for the administration fees, the Manager pays all costs and expenses (other than certain specified fund costs) required to operate the Fund that are not included in management fees. ## Other Related Party Transactions

The Manager is wholly owned by IGM Financial Inc., which in turn is a subsidiary of Power Corp. of Canada. Companies related to Power Corp. of Canada are therefore considered affiliates of the Manager. At September 30, 2023, the Fund held the following investment(s) in companies affiliated with the Manager: \$0.003 million invested in securities issued by IGM Financial Inc., \$0.01 million invested in securities issued by Groupe Bruxelles Lambert SA and \$0.04 million invested in securities issued by Pernod Ricard SA. The investment(s) represented 0.1% of the Fund's NAV. In making the investment(s), the Manager relied on the approval of the Mackenzie Funds' Independent Review Committee. The Independent Review Committee issued the approval on the basis that the investment(s) would be made in compliance with the Manager's policies. The Manager's policies are designed to ensure that any related party transaction (i) is made free from any influence by an entity related to the Manager and without taking into account any considerations relevant to an entity related to the Manager; (ii) represents the business judgment of the Manager, uninfluenced by considerations other than the best interests of the Fund; and (iii) achieves a fair and reasonable result for the Fund.

At September 30, 2023, Mackenzie had an investment of \$0.03 million in the Fund (0.1% of the Fund's NAV).

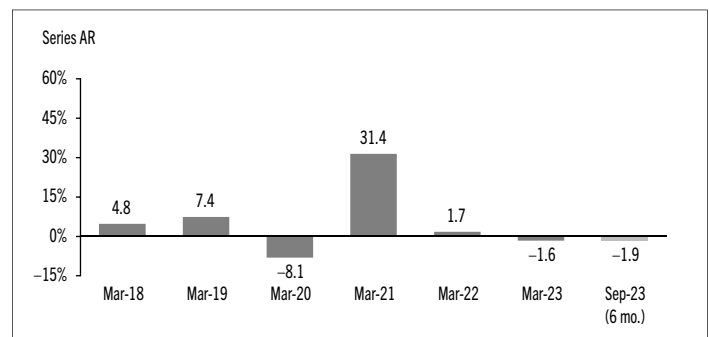
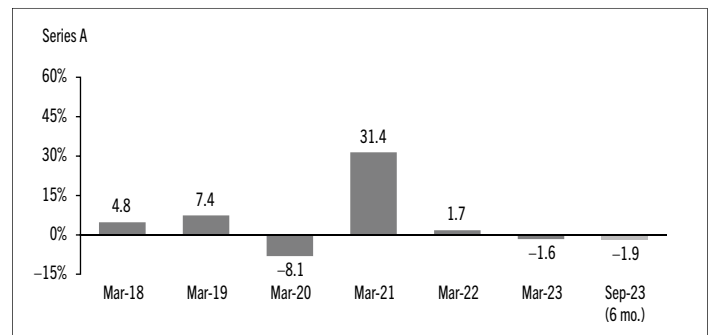
## Past Performance

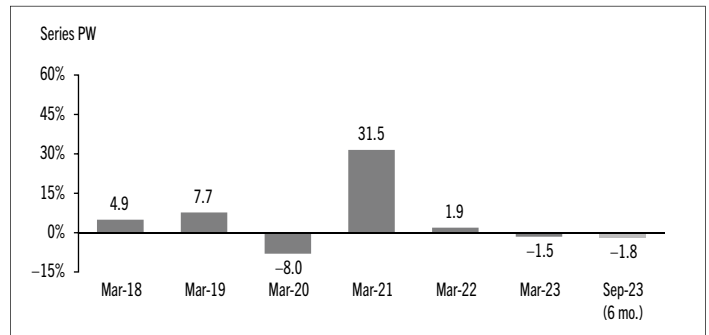
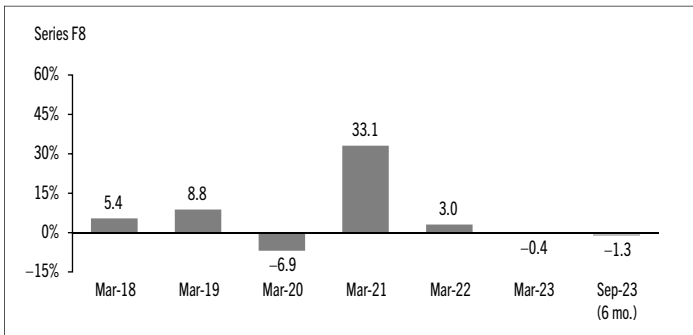
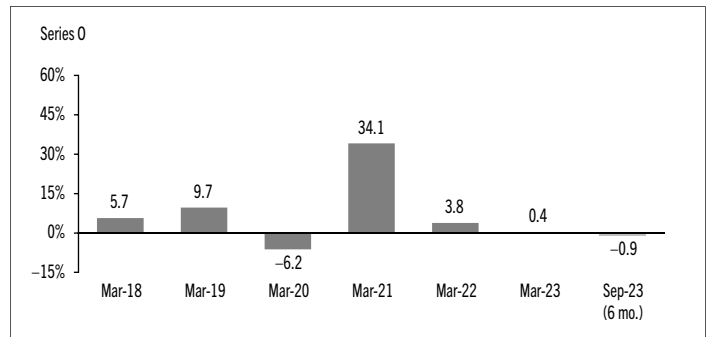
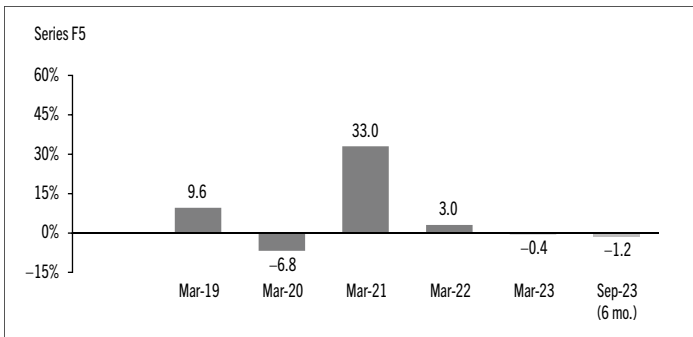
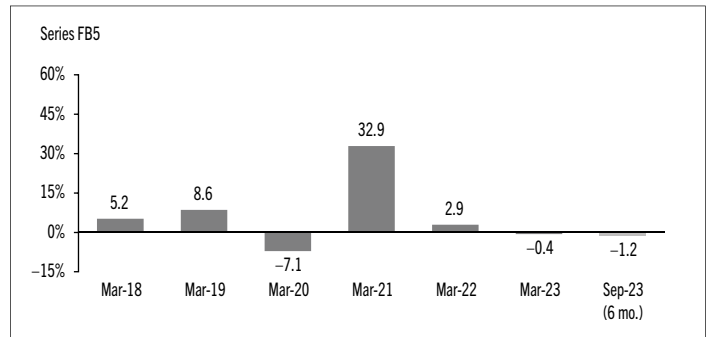
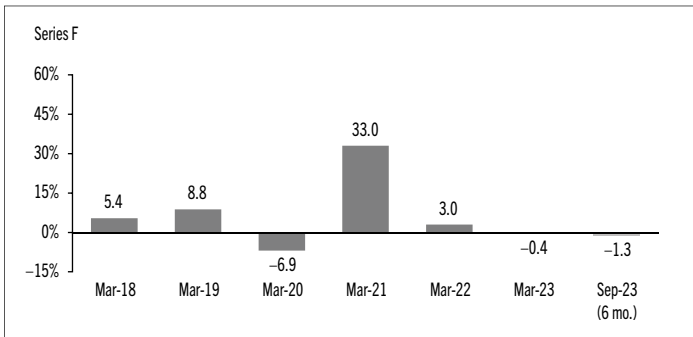
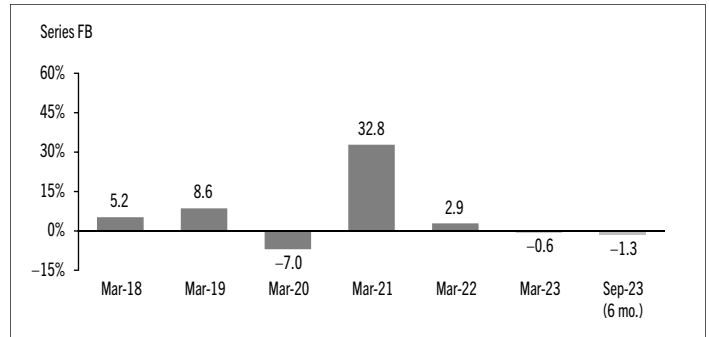
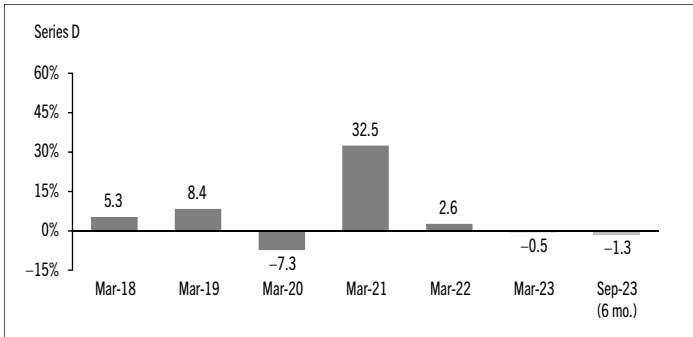
## Year-by-Year Returns

## Management Fees

The management fee for each applicable series is calculated and accrued daily as a percentage of its NAV. The Fund's management fees were used by the Manager to pay for the costs of managing the investment portfolio of the Fund and/or the underlying fund(s), as applicable, including providing investment analysis and recommendations, making investment decisions, making brokerage arrangements for the purchase and sale of the investment portfolio, and providing other services. The Manager also used the management fees to fund sales commissions, trailing commissions and any other compensation (collectively "distribution-related payments") to registered dealers and brokers whose clients invest in the Fund.

LBC Financial Services Inc. ("LBC") is the principal distributor for the LBC series securities of the Fund (as listed under *Fund Formation and Series Information*) and receives a portion of the management fees that the Fund pays to the Manager. Under this arrangement, LBC was entitled to approximately 25% of the total management fees that the Manager received from the LBC series of all Mackenzie funds during the period. The Manager is responsible for paying all distribution-related payments to LBC-authorized dealers whose clients invest in the LBC series of the Fund.

The following dealers affiliated with the Manager may be entitled to distribution-related payments from the Manager on the same basis as unrelated registered brokers and dealers: IPC Securities Corporation, Investors Group Securities Inc., IPC Investment Corporation and Investors Group Financial Services Inc.

The Manager used approximately 42% of the total management fee revenues received from all Mackenzie funds during the period to fund distribution-related payments to registered dealers and brokers. In comparison, such distribution-related payments for the Fund represented on average 36% of the management fees paid by all applicable series of the Fund during the period. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions and sales commissions paid for that series.
